# **Cabinet Decisions**

#### Cabinet Approves ₹8,308 Crore Capital Region Ring Road Project in **Odisha**

The Union Cabinet has approved the construction of a 6-Lane Access-Controlled Capital Region Ring Road (CRRR), including the Bhubaneswar Bypass, in Odisha under the Hybrid Annuity Mode (HAM). The project, spanning 110.875 kilometers, will be developed at a capital cost of ₹8,307.74 crore. This ambitious infrastructure initiative is expected to be a game-changer for Odisha, particularly for the fastgrowing capital region around Bhubaneswar, Khordha, and Puri. The construction of the ring road will significantly strengthen connectivity by decongesting urban traffic in the capital and easing the movement of goods and people to industrial hubs, ports, and tourist destinations in the state. It will also reduce travel time, enhance road safety, and improve logistics efficiency across the region. Built as a modern, access-controlled expressway, the project will cater to increasing vehicular traffic, provide seamless entry and exit points, and align with national standards of highway development. The ring road is also expected to support economic activities, particularly in sectors such as IT, education, healthcare, tourism, and manufacturing-areas where Bhubaneswar and its surroundings are rapidly emerging as growth engines. The use of the Hybrid Annuity Model will ensure efficient financial structuring by reducing upfront capital burden on the government while ensuring private sector participation and accountability in delivery. The model has already been successfully implemented in several other national highway projects, striking a balance between risk-sharing and long-term project sustainability. The CRRR project is aligned with the vision of creating world-class infrastructure under Bharatmala Pariyojana and is expected to generate significant employment during the construction phase. Once operational, it will boost trade, tourism, and ease of living, further positioning Odisha as a key destination for sustainable development and investment.

#### Cabinet Approves Greenfield Airport at Kota-Bundi, Rajasthan with **Investment of ₹1,507 Crore**

The Union Cabinet has approved the development of a Greenfield Airport at Kota-Bundi in Rajasthan with an estimated investment of ₹1,507 crore. This strategic initiative is aimed at strengthening air connectivity in Rajasthan, enhancing regional accessibility, and supporting the growing economic and tourism potential of the Kota region. The Greenfield Airport project will be developed as per international standards with state-of-the-art passenger facilities, sustainable design features, and the capacity to handle both domestic and future international traffic. Once completed, the airport will serve as a vital infrastructure link for Kota, Bundi, Jhalawar, and nearby districts, providing seamless connectivity to major cities across India. The project is also expected to generate significant employment opportunities during both construction and operational phases. In addition, it will facilitate the faster movement of goods, especially agricultural and horticultural products from the region, opening up new markets and enhancing farmers' incomes. Development of the Greenfield Airport at Kota-Bundi is in alignment with the Government's UDAN (Ude Desh ka Aam Nagrik) scheme to strengthen regional air connectivity and promote balanced growth across states. This project will stand as a symbol of Rajasthan's growing integration with national development priorities and is expected to play a pivotal role in boosting the region's socio-economic transformation.



# **Industry Developments**

### Overall

#### Govt plans sector-specific relief as US tariffs hit exporters

The central government is working on measures to support exporters hit by steep US tariffs. Instead of a broad loan guarantee scheme, the focus will be on sector-specific credit lines and risk cover, reported Economic Times. Exporters had demanded an Emergency Credit Line Guarantee Scheme (ECLGS)-style programme that would provide collateral-free working capital and government-backed risk cover.

In a written reply to the Rajya Sabha on 18 August 2025, the minister of state (MoS) for civil aviation Murlidhar Mohol provided a data that showed that as many as 5,706 flights were cancelled due to regulatory and geopolitical issues this year till 30 June 2025.

#### Government considering GST cut on small cars

The government is considering a major cut in GST on small cars, potentially reducing the tax from 28 per cent to 18 per cent as part of a broader effort to simplify the country's tax structure and stimulate demand in the auto sector. This move is expected to make entry-level cars more affordable, encouraging sales in a segment that has seen sluggish growth.

### **Banking and Financial Services**

#### Banks scaling up on UPI credit line

Credit lines on the Unified Payments Interface (UPI) are likely to gain traction as banks such as ICICI Bank and Karnataka Bank prepare to disburse small-value loans through UPI apps. The National Payments Corporation of India (NPCI) had enabled pre-sanctioned credit lines on UPI in September 2023, but most lenders delayed adoption due to technical challenges and regulatory clarifications.

State Bank of India (SBI) has raised home loan rates by 25 basis points (bps) for new borrowers, in spite of the Reserve Bank of India's reportate cut to 5.5 per cent. The bank has increased the upper band of interest rates, revising the range from 7.50-8.45 per cent to 7.50-8.70 per cent.

#### **IOCL plans SAF production by December 2025**

Indian Oil Corporation will start sustainable aviation fuel (SAF) production in December 2025, according to chairman A. S. Sahney. The SAF production unit is located at the company's Panipat refinery in Haryana. It will have an annual capacity of 35,000 tonnes and use used cooking oil (UCO) as feedstock.

Equipped with 80 intensive care unit (ICU) beds and eight modular operation theatres, the hospital offers comprehensive services across all major specialties.

Directions have been issued to the state public works department to identify a suitable site for the bridge from Gharat Nala to Ghanghar at Sunni. Once the site is identified, an estimate for the construction of the double-lane bridge will be prepared.

#### Karnataka Assembly passes various Bills

The Karnataka Platform-Based Gig Workers (Social Security and Welfare) Bill, on the other hand, proposes a welfare fee of one to five per cent of the payout to the worker during each transaction, for different categories of aggregators or platforms.

### Karnataka LC passes Land Reforms and Certain Other Laws (Amendment) Bill

The Karnataka Legislative Council (LC) passed the Karnataka Land Reforms and Certain Other Laws (Amendment) Bill. The legislation allows the conversion of agricultural land for setting up micro, small and medium enterprise (MSME) units up to 0.8 hectares. There is no need to apply for land conversion for the establishment of such units, as the Bill has removed the conversion clause.

The Karnataka government has decided to commence the exercise of removing ineligible families having below poverty line (BPL) cards soon after the end of the monsoon session of the state Assembly. Around 1.5 million families had been identified to be ineligible to receive BPL cards in the past and action would be initiated to delete these families from the BPL list.



### Kerala

#### Kerala minister recommends implementing reservation for transgenders in jobs

The Kerala higher education department has recommended implementing reservation for transgender individuals in government jobs. State higher education minister informed that the public service commission (PSC) has been requested to consider this demand.

The centre is being established under the Farm Sector Promotion Fund of the National Bank for Agriculture and Rural Development (NABARD).

### **Uttar Pradesh**

#### UP govt sanctions Rs.450 mln for development of temples in Gorakhpur

The Uttar Pradesh government has sanctioned Rs.450 million for projects aimed at the development of ancient temples in rural areas of Gorakhpur. The city is home to several prominent religious sites, including Gorakhnath Temple, Shri Digambar Jain Temple, Jatashankar Gurudwara, Ramkrishna Dev Temple, Ancient Kalika Sthan, Chitragupta Temple, Sant Kabir Ashram and Shri Ram Janaki Temple.

This framework sets the stage for formal negotiations and aims to unlock unutilized trade opportunities, boost investment flows, and build a stronger, long-term India-EAEU economic partnership.
