Overall

4 sectors drive over half of India's exports in FY25

Agriculture, pharmaceuticals, electronics, and engineering goods together made up more than 50 per cent of India's merchandise exports in 2024-25. Engineering goods led with a 26.7 per cent share of the total USD 437.4 billion exports, followed by agriculture at 11.9 per cent, electronics at 8.8 per cent, and pharmaceuticals at seven per cent.

Output of 8 core industries rises by 0.5% in April 2025

The index of eight core industries rose by 0.5 per cent on a year-on-year basis in April 2025. The growth was lower than the 4.6 per cent growth registered in the preceding month. It was also the lowest level seen in the past eight months. Five of the eight core industries reported a rise in production, while three reported a fall.

Imports of US crude doubles in April

India's crude oil imports from the United States (US) surged to 0.33 million barrels per day (mbpd) in April 2025 from 0.17 mbpd in the same month last year and 0.24 mbpd in March 2025, according to energy cargo tracker Vortexa.

Commercial PNG connections up by 164%, industrial network rises by 308%

Commercial piped natural gas (PNG) connections have increased by 164 per cent in the last ten years, while industrial connections have grown remarkably by 308 per cent, according to the minister of petroleum and natural gas Hardeep Singh Puri.

The Chhattisgarh government has directed all district collectors to allocate government land for setting up bio-compressed natural gas plants in urban local bodies for processing biowaste and agricultural waste.

Petrol consumption rises by 10.5%, diesel up by 2%

Petrol consumption in the first half of May 2025 increased by 10.5 per cent to 1.5 million tonnes from 1.4 million tonnes during the same period last year, driven by a rise in summer travel, according to media reports. Diesel sales also saw a modest growth of two per cent, reaching 3.4 million tonnes compared to 3.3 million tonnes a year earlier.







Agri & Food processing

India's agri sector expected to grow at 3-3.5% in 2025-26

India's agriculture sector is expected to grow at 3-3.5 per cent in 2025-26, according to Shivraj Singh Chouhan, Union minister of agriculture and farmers' welfare. This would be driven by record crop production of 2024-25. The India Meteorological Department has predicted above normal rainfall for the current monsoon season June-September 2025.

Sugar consumption expected to be lower at 28 million tonnes

Sugar consumption in India is expected to be lower at around 28 million tonnes (mt) in the current sugar season October 2024-September 2025. This would be on account of subdued demand, according to the Indian Sugar and Bio Energy Manufacturers Association (ISMA).

Oilmeal exports from India remained flat in April 2025 on account of lack of demand in the international market. Oilmeal exports in April were around 4,65,863 tonnes compared to 4,65,156 tonnes in April 2024, according to data compiled by the Solvent Extractors' Association of India (SEA).

Shree Cement eyeing acquisitions

Shree Cement is evaluating at least two or three assets for acquisition as it targets 80 million tonnes (mt) of production capacity while continuing to maintain its cost leadership, managing director Neeraj Akhoury said. The company is set to have 71 mt production capacity by September 2025 with a target of 80 mt by 2027-28.

The government would decide on mega steel plant in Koppal in Kalyana Karnataka region after going through the deputy commissioner's report, according to Chief Minister Siddaramaiah. Baldota group signed up with the government at the global investor summit in February 2025 proposing to invest Rs.540 billion on a greenfield steel mill.







Consumer Market

Summer product sales dip in spite of heatwave forecast

Companies making summer products like air-conditioners, beverages and talcum powders have cut production by up to 25 per cent, according to media reports. This is due to weak sales in April and early May, despite earlier forecasts of strong heatwaves.

Quick commerce platforms have accounted for only 2-4 per cent of the overall sales of FMCG firms, according to media reports. This is in spite of quick commerce being the fastest growing segment for FMCG firms over the last two years.

Commerce and industry minister Piyush Goyal may extend the timeline for implementing the quality control order (QCO) on electrical appliances. The QCO, issued on 20 September 2024, covers the safety of household and commercial appliances. Industry flagged issues like unclear coverage of DC and battery appliances, lack of test labs and manuals, and delays in BIS certification.

Sun Pharma gets USFDA nod for advanced LED BLU-U PDT device

Sun Pharmaceuticals has secured United States Food and Drug Administration (USFDA) approval for its LED BLU-U Blue Light Photodynamic Therapy (PDT) device. The device is used in combination with Levulan Kerastick for treating actinic keratoses.

Accretion Pharmaceuticals' initial public offering (IPO) of Rs.297.50 million was oversubscribed by 7.6 times. The IPO comprises a fresh issue of 2.94 million shares priced at Rs.97 to Rs.101 each. It closed on 16 May 2025 and will likely list on the NSE SME platform on 21 May 2025.

Indian Bank introduces two new FDs offering 7.15%, 6.8% interest

Indian Bank launched two new special retail term deposit schemes, IND SECURE and IND GREEN, effective from 8 May 2025. At the same time, the bank discontinued its IND SUPER 400 Days and IND SUPREME 300 Days schemes.

The National Bank for Financing Infrastructure and Development (NaBFID) has announced a sanction target of Rs.1.2 trillion for 2025-26, with a long-term goal of expanding its asset base to Rs.4 trillion by 2028-29, according to its managing director Rajkiran Rai G.

Bajaj Finance cuts deposit rates, others may follow

Bajaj Finance has reduced deposit rates by up to 50 basis points, matching recent policy rate cuts, according to Vijaykuppa, CEO, Incred Money. This is their second reduction, with long-tenure deposits seeing bigger cuts. An 18-month deposit now offers 7.4 per cent, while 24-60 month deposits pay 7.25 per cent.

Bajaj Auto said that its Netherlands-based arm, Bajaj Auto International Holdings BV, Netherlands (Bajaj Auto BV), is in negotiations and exploring various alternatives to participate in the restructuring of KTM AG following a plan approved by the creditors of the Austrian motorcycle manufacturer.

The Karnataka government has decided to shut down Jan Aushadhi Kendras operating within state-run hospital premises. This ensures that patients get free medicine in government hospitals and bars public hospitals from recommending or selling medicines from outside sources.

India's orthopaedic and cardiac implant market is projected to reach USD 4.5-5 billion by 2027-28, up from USD 2.4-2.7 billion in 2023-24, according to a CareEdge Ratings report. The sector's strong growth is driven by rising healthcare demand, improved insurance coverage and increased infrastructure.

Airtel calls rivals for collaboration to fight cyberfraud

Bharti Airtel has approached its rivals, such as Reliance Jio, Vodafone Idea (Vi) and Bharat Sanchar Nigam Limited (BSNL) to create a Joint Telecom Fraud Initiative to curb the growing menace of malicious uniform resource locator (URL) links.

Mid-cap IT firms outshine large players in deal wins & execution

Mid-sized IT companies such as Coforge, LTIMindtree and Persistent Systems have outperformed their larger counterparts such as Tata Consultancy Services (TCS), Infosys and HCLTech in securing and delivering large contracts.

The Centre has approved to set a Rs.37 billion semiconductor plant in Jewar, Uttar Pradesh, marking the sixth semiconductor plant in the country. A joint venture between HCL and Foxconn will develop the project. The upcoming plant will start production in 2027.

The Indian IT sector is experiencing a slowdown in deal signings after a brief surge at the start of 2025. Apparel exporters body inks pact with GBCI

Apparel Export Promotion Council has partnered with Green Business Certification Institute to boost sustainable manufacturing. The partnership will help India increase the number of Leadership in Energy and Environmental Design certified garment factories.

Air India likely to ink over 10 new codeshare agreements this fiscal year

Senior officials said that Air India is likely to ink over 10 new codeshare agreements this fiscal year. This would significantly expand the carrier's reach across North America, Europe, and Africa. At present, the airline has 19 codeshares, compared to none during its acquisition by the Tata Group about two years ago.
