## **Industry Developments**

## Overall

#### **Manufacturing PMI gains in Oct 2025**

HSBC's manufacturing Purchasing Managers' Index (PMI) rose to 59.2 per cent in October 2025. This is an uptick from the 57.7 per cent increase in September 2025. Higher production was aided by strong demand, new clients, improvement in efficiency and technological investments. But, the international sales registered a slower increase.

#### India, EU intensify FTA talks to resolve key issues

Commerce and Industry Minister Piyush Goyal met European Union Commissioner for Trade and Economic Security Maros Sefcovic to review progress on the proposed India-EU Free Trade Agreement and strengthen trade and investment ties. The discussions follow Goyal's visit to Brussels on 27-28 October 2025 and a virtual meeting on 3 November 2025.

#### India, New Zealand resume FTA talks to boost trade ties

India and New Zealand began the fourth round of free trade agreement (FTA) negotiations in Auckland on 3 November 2025, aiming to build a balanced and comprehensive partnership. #### AWL Agri aims to grow its high-margin packaged foods segment

AWL Agri Business aims to grow its higher-margin packaged foods segment in order to reduce reliance on the unpredictable edible oil market. The company aims to increase its share of the category's total volume to 30 per cent over the next five years, according to Shrikant Kanhere, the chief executive officer (CEO) of the company.

#### Farmers in Maharashtra urge CCI to relax cotton procurement norms

Farmers and leaders of the Shetkari Sanghatana in Vidarbha, Maharashtra's cotton belt, have urged the Cotton Corporation of India (CCI) to relax its cotton procurement norms. This comes after heavy rains damaged the standing cotton crop and raised its moisture content. Currently, CCI procures cotton only when its moisture content is below 12 per cent.

#### Maize prices fall below MSP

Maize prices in India have declined below the minimum support price (MSP) of Rs.2,400 per quintal. The current modal prices across mandis in various states range between Rs.1,300-2,100 per quintal. This decline was due to record crop expectations and reduced demand from ethanol producers and poultry feed makers.



## **Aviation**

#### BOC Aviation ink sale-and-leaseback deal with Akasa Air for 3 Boeing 737-8 aircraft

BOC Aviation has signed a sale-and-leaseback deal with Akasa Air for three Boeing 737-8 aircraft. Powered by CFM LEAP-1B engines, the planes will be delivered from January 2026 and leased on longterm operating terms. The chief of governance and strategic acquisitions at Akasa Air, Priya Mehra, said that the agreement fits with the it's growth plans.

Madhya Pradesh Chief Minister (CM) Mohan Yadav has launched the state's first helicopter service aimed at boosting tourism by connecting major cities and religious sites. #### SUVs continue to dominate passenger vehicle sales even after GST cut, says Hyundai Motor India

Hyundai Motor India reports that SUVs continue to dominate passenger vehicle sales even after recent tax reductions, with buyers increasingly choosing larger or mid-sized SUVs over hatchbacks and sedans. Many customers are reallocating their budgets to upgrade to SUVs rather than opt for smaller cars, reflecting a clear market shift toward this segment.

Mahindra & Mahindra is set to record double-digit growth in 2025-26, supported by robust demand across its passenger vehicles, commercial vehicles, and tractor segments. The company experienced strong bookings and retail sales during the festive season, with continued momentum afterward.

TVS Motor Company plans to introduce the British motorcycle brand Norton in India by mid-2026, following its debut in the UK and Europe earlier that year. The company will produce Norton's highperformance 'Manx' models in the UK and manufacture the 'Atlas' range at its Hosur plant in India.



## **Banking and Financial Services**

#### NaBFID to be renamed as Infrastructure Development Bank

The National Bank for Financing Infrastructure and Development (NaBFID) is set to be renamed as the Infrastructure Development Bank (IDB), according to media reports. The rebranding aims to align the institution with global peers such as the Asian Development Bank and the International Finance Corporation.

#### Warburg Pincus plans full exit from IndiaFirst Life Insurance

Warburg Pincus is in advanced discussions with investors to offload its 26 per cent stake in IndiaFirst Life Insurance, valuing the insurer at around Rs.100 billion, according to media reports. Bids are expected in early December 2025, with the deal likely to be finalised by March 2026.

#### Microfinance portfolio contracts 16.5%, asset quality improves

Gross microfinance portfolio fell by 16.5 per cent year-on-year to Rs.3.5 trillion as of 30 September 2025 from Rs.4.1 trillion a year earlier and 3.8 per cent sequentially, according to CRIF High Mark. The number of active low-income borrowers dropped by 19.3 per cent year-on-year and 6.3 per cent quarter-on-quarter to 124 million.

## **Energy & Natural Resources**

#### Tanker with Russian oil holding off Mumbai

The Ailana tanker, carrying Russian crude from the recently sanctioned Rosneft, has been holding off Mumbai for a week amid heightened scrutiny of Indian refiners' purchases following United States (US) sanctions. The tanker arrived near the Indian commercial hub on 24 October 2025 and has remained nearly stationary since, with its cargo still on board, according to media reports.

#### Crude oil imports from US rise, from Russia fall

Crude oil imports from the United States (US) have surged to 0.57 million barrels per day (mbpd) in October 2025, while imports from Russia fell by eight per cent, declining to 1.62 mbpd from 1.75 mbpd in October 2024.

#### Closing stock of coal at power plants to be higher in 2025-26

Closing stock of coal at domestic coal-based power plants is expected to be higher by 6.7 million tonnes (MT) at 62 MT in 2025-26 compared to the opening stock. Stock at power plants was generally higher in the current financial year due to higher fuel supply and lower power demand.

#### Govt proposes new rules for renewable energy producers

The government has proposed new rules by the Central Electricity Regulatory Commission (CERC) for renewable energy producers. These rules would require them to closely match their estimated power supply with actual generation, starting in April 2026.



## Healthcare

#### Novo Holdings to boost India investments in specialty healthcare

Novo Holdings, the controlling shareholder of Novo Nordisk, is intensifying its India focus with plans to invest in single-specialty hospitals and contract drug manufacturing to capture growth in high-potential healthcare segments. The Denmark-based investment arm has expanded its deal size to between USD 50 million and USD 125 million and established a Mumbai team to scale its operations.

#### Centre approves healthcare project for Himachal Pradesh

The central government has approved a Rs.14.2 billion healthcare infrastructure strengthening project for Himachal Pradesh with assistance from the Japan International Cooperation Agency (JICA). The funding structure includes Rs.11.3 billion as external aid and Rs.2.8 billion as state share. Major medical colleges in Hamirpur, Nahan, Mandi, Tanda, Chamba and Shimla will be upgraded under this project.

It has been equipped with 171 beds, a nine-bedded medical intensive care unit (ICU), four operation theatres, a labour room with four suites and 12 outpatient departments.

#### PM lays foundation stones for transformative road projects

Under the partnership, Cognizant will use Anthropic's Claude AI to train its 350,000 associates across key corporate functions, engineering and delivery teams. Cognizant will also use Claude code to enhance coding tasks, testing, documentation and DevOps workflows.

## Alembic Pharma's September quarter profit rises by 21% on strong international and API growth

Alembic Pharmaceuticals posted a 21 per cent year-on-year (y-o-y) increase in consolidated net profit to Rs.1.85 billion for the September 2025 quarter, supported by robust growth across international generics and active pharmaceutical ingredients (API) segments. Revenue rose by 16 per cent to Rs.19.1 billion, driven by higher United States (US) and ex-US sales and strong export demand in APIs.

India is set to become a major global production centre for semaglutide active pharmaceutical ingredients (API) following China, as leading pharmaceutical firms including Aurobindo, Dr Reddy's, Lupin, Alembic and Biocon expand their peptide syntheses and API manufacturing capacities.

#### NPPA to review knee implant price cap

The National Pharmaceutical Pricing Authority (NPPA) is set to review the ceiling prices of knee implants, as the current price control order has been extended until 15 November. The regulator first capped prices in 2017 under the Drug Price Control Order (DPCO) 2013, reducing patient costs by nearly 70 per cent.



## Regional Developments

## Andhra Pradesh

#### Andhra Pradesh govt collects Rs.30.2 bln in net GST revenue in October

The Andhra Pradesh government collected Rs.30.2 billion in net Goods & Services Tax (GST) revenue in October 2025. This is the second-highest collection in October since GST was introduced in 2017, as per the state commercial taxes department. The state registered an 8.7 per cent growth in net GST collections, as compared to October 2024, despite rate reductions on several goods.

The Andhra Pradesh government has decided to integrate advanced technologies across the industrial, IT and micro, small & medium enterprises (MSME) sectors. The aim is to transform the state into a global centre for industrial investment and innovation, as per The New Indian Express.

#### MoU signed for co-treatment of faecal sludge at STPs in HP

The state government has signed an agreement with the state jal shakti vibhag (JSV) and rural development department for the co-treatment of faecal sludge at existing sewage treatment plants (STPs). The initiative aims to strengthen wastewater management systems and curb pollution in water bodies.

## Haryana

#### Haryana CM releases Rs.2,100 under `Deen Dayal Lado Lakshmi' scheme

On 31 October 2025, Haryana Chief Minister (CM) Nayab Singh Saini released Rs.2,100 each to 522,162 eligible women beneficiaries under the 'Deen Dayal Lado Lakshmi' scheme. The scheme is aimed at promoting self-reliance and economic empowerment. A total of 697,697 women, including 46,168 unmarried, had applied for the monthly stipend.

On 31 October 2025, the Haryana government notified the Haryana Jan Vishwas (Amendment of Provisions) Ordinance. It also rationalises penalties across several departments.

## Karnataka

#### Karnataka tops list of large states in terms of growth in GST collections

Karnataka topped the list of large states in terms of growth in Goods and Services Tax (GST) collections, since the GST rationalisation measure was implemented from 22 September 2025. Maharashtra, Karnataka, Gujarat, Tamil Nadu and Haryana together contributed over 40 per cent of the total GST revenue, underscoring their role as major consumption & production hubs.

## Kerala

#### Kannur gets new multi-level car parking centre near Jawahar Stadium

On 1 November 2025, Kerala's Kannur Municipal Corporation opened a new multi-level car parking centre near Jawahar Stadium. The facility has been built under the Atal Mission for Rejuvention & Urban Transformation (AMRUT) project, as per The Hindu. The multi-level parking facility comprises six floors with four operational units capable of accommodating 31 cars on each floor.

#### IR to introduce third Vande Bharat train from Kerala

The Indian Railways (IR) has decided to introduce a new Vande Bharat train from Kerala, which will make it the third such semi-high-speed train in the state. The new train will be operated and maintained by the Southern Railway (SR) zone. It is expected to improve connectivity between Kerala and Karnataka's Bengaluru.

#### MoU signed for Panchmauli-Devalipada hydroelectric project in **Maharashtra**

The Maharashtra government has signed an MoU worth Rs.80 billion with GSC PSP Maha Private Limited of Haryana for the Panchmauli-Devalipada pumped storage hydroelectric project in Dhule and Nandurbar districts. The project, with an installed capacity of 1,500 MW, is expected to create about 2,500 jobs.

#### Maharashtra govt declares leprosy `notifiable disease'

The Maharashtra government has declared leprosy a 'notifiable disease'. The aim is to curb its spread and ensure timely treatment for all affected individuals. The directive in this regard was issued by the state health department notification. It requires all doctors and healthcare institutions to report any diagnosed leprosy case within two weeks to district or municipal health authorities.

The move will attract more developers by easing certain regulatory and cost-related provisions, ultimately speeding up stalled or delayed urban renewal projects.



### **Tamil Nadu**

#### Tamil Nadu leads in demand for work under MGNREGS in Oct

Tamil Nadu alone accounted for about 22 per cent of the total demand under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) in October 2025. As many as 2.8 million people from the state sought work under the scheme. This was followed by Uttar Pradesh, the country's most populous state, where 1.1 million people demanded work.

#### Ford to invest Rs.32.5 billion in Tamil Nadu plant

Ford plans to invest about Rs.32.5 billion to restart operations at its former plant near Chennai, Tamil Nadu, focusing on producing next-generation engines. The facility is expected to begin production in 2029 with an annual capacity of around 235,000 units, generating hundreds of direct and indirect jobs.

#### **Tamil Nadu Governor approves 9 Bills**

On 31 October 2025, Tamil Nadu Governor RN Ravi approved as many as nine Bills passed by the state Assembly. The Governor's decision follows the Supreme Court's observation that Governors must not delay or withhold assent indefinitely and that such inaction undermines the principles of responsible governance. The Fiscal Responsibility (Amendment) Bill seeks to reinforce fiscal prudence, transparency and accountability in public finance.

He has instructed the immediate disbursal of funds to clear long-pending liabilities inherited from the previous government.



## **Uttar Pradesh**

#### State approves 38 private logistics & warehousing projects

The Uttar Pradesh government has approved 38 private logistics and warehousing projects worth Rs.26 billion across key cities. These include Lucknow, Ghaziabad, Greater Noida and Rampur. The projects fall under the UP Warehousing and Logistics Policy.

## International Developments

#### Minister of Commerce & Industry Shri Piyush Goyal visited New Zealand to strengthen bilateral economic and trade relations

Union Minister of Commerce & Industry, Shri Piyush Goyal, visited New Zealand to strengthen bilateral economic and trade relations between the two nations. At the India-New Zealand Business Forum, organised by the Auckland Business Chamber, the Minister joined Hon. Todd McClay, Minister for Trade of New Zealand, for a Fireside Chat. He urged both nations to explore innovative avenues of cooperation to further strengthen their economic partnership. The Minister highlighted the vast potential for collaboration in key sectors such as maritime, forestry, sports, education, technology, and tourism. He also noted that this was the first visit to New Zealand by such a large Indian business delegation, reflecting the confidence and dynamism of Indian industry in alignment with the vision of Viksit Bharat.

Both countries engaged constructively to build on the momentum from previous rounds, aiming to bridge remaining gaps and move closer to an early conclusion of the agreement. India and New Zealand reaffirmed their shared commitment to shaping a progressive and inclusive trade framework that promotes sustainable growth and mutual prosperity.



#### 9th Round of India-Peru Trade Agreement and 3rd Round of India-Chile **CEPA** negotiations concluded

India successfully concluded two significant rounds of trade negotiations with partner countries in Latin America. The 9th Round of India-Peru Trade Agreement negotiations took place in Lima, Peru, where substantial progress was achieved across key chapters of the proposed agreement, including Trade in Goods and Services, Rules of Origin, Technical Barriers to Trade, Customs Procedures, Dispute Settlement, and Critical Minerals. Similarly, the 3rd Round of India-Chile Comprehensive Economic Partnership Agreement (CEPA) negotiations was held in Santiago, Chile, covering a broad range of areas such as Trade in Goods and Services, Investment Promotion, Rules of Origin, Intellectual Property Rights, TBT/SPS measures, Economic Cooperation, and Critical Minerals.
