Cabinet Decisions

Cabinet approves ₹8,146 Crore Tato-II Hydroelectric Project in Arunachal Pradesh

The Union Cabinet has approved an investment proposal for the construction of the 700 MW Tato-II Hydro Electric Project in the Shi Yomi District of Arunachal Pradesh, with a total outlay of Rs. 8,146.21 crore. The project, featuring four turbines each generating 175 MW, is expected to be completed within 72 months. It will produce around 2,738 million units of energy, significantly improving power supply in Arunachal Pradesh and aiding in the stabilization of the national grid. This project will also contribute to the region's economic development through job creation, improved infrastructure, and enhanced local facilities. The hydroelectric project aligns with clean energy goals by harnessing renewable water resources in this strategically important region.

Cabinet approves ₹4,600 Crore Semiconductor Units in Odisha, Punjab, and Andhra Pradesh to Boost Domestic Manufacturing

The Union Cabinet has approved the establishment of semiconductor manufacturing units in Odisha, Punjab, and Andhra Pradesh with a total investment outlay of Rs. 4,600 crore. These projects are part of the India Semiconductor Mission, aiming to strengthen the domestic semiconductor ecosystem and reduce import dependency. The new units, including the country's first commercial Silicon Carbide (SiC) compound semiconductor fab in Odisha, will cater to growing demands in telecom, automotive, consumer electronics, and defense sectors while creating skilled employment opportunities. This initiative supports India's ambition for self-reliance and global competitiveness in electronics manufacturing.

The Union Cabinet has approved the Lucknow Metro Rail Project Phase-1B, spanning 11.165 km and comprising 12 strategically located metro stations. With a total project outlay of ₹5,801 crore, this phase aims to enhance urban mobility, reduce traffic congestion, and provide a faster, safer, and more eco-friendly mode of transport for commuters. It is expected to boost connectivity within the city, promote economic activity, and support sustainable urban development, making public transport more efficient and accessible.

The Union Cabinet has approved four new components under the Special Development Packages (SDPs) for Assam and Tripura, with a central outlay of ₹4,250 crore—₹4,000 crore for Assam and ₹250 crore for Tripura. Assam will add ₹3,000 crore, taking total investment to ₹7,250 crore. Spanning five years in Assam and four in Tripura, the projects aim to boost infrastructure, socio-economic welfare, jobs, and tourism, benefiting underserved tribal and ethnic groups to promote peace, stability, and inclusive growth.

Focused on digitalization, gender inclusion, and market alignment, it aims to benefit 7.5 lakh students, foster innovation, and reduce graduate unemployment with support from premier institutions.

Paid in 12 tranches, the support will help sustain procurement, manage debt, and ensure uninterrupted, affordable LPG supply, benefiting millions of households and supporting schemes like PM Ujjwala Yojana while safeguarding the financial health of OMCs.

India, Oman FTA to be signed soon

The signing of the India-Oman Comprehensive Economic Partnership Agreement (CEPA) is expected shortly, as per a government official. Formal talks for the agreement began in November 2023. Oman is India's third-largest export market in the Gulf Cooperation Council (GCC), with bilateral trade exceeding USD 10 billion in 2024-25.

India's proposed free trade agreement with the European Union (EU) could unlock access to a USD 875 billion market and bring tariff parity with ASEAN countries, according to Boston Consulting Group India head Rahul Jain. The UK-India FTA, signed last month, is set to boost bilateral trade by USD 34 billion and offer duty-free access for 99 per cent of Indian exports.

Kharif sowing up 4% as of 8 August 2025

Area sown under kharif crops was reported at 99.6 million hectares as of 8 August 2025. This is four per cent higher than the area covered during the corresponding period last year. Acreage under rice increased by 12.1 per cent to 36.5 million hectares and that under coarse cereals also increased by 4.5 per cent to 17.9 million hectares.

RBI approves AU SFB's transition to universal bank

The Reserve Bank of India has given 'in-principle' approval to AU Small Finance Bank (AU SFB) to transition into a Universal Bank, according to media reports. AU SFB applied for the conversion in September 2024, meeting the RBI's eligibility norms, which include the minimum paid-up capital/net worth requirement for Universal Banks and a proven track record of over five years.

IOCL, HPCL pick up 22 mn barrels of non-Russian crude

India-Nigeria Bilateral Defence Talks Held

Raksha Rajya Mantri Shri Sanjay Seth held a bilateral meeting with Dr Bello Mohammed Matawalle, Nigeria's Minister of State for Defence, in New Delhi on August 12, 2025. The two leaders engaged in in-depth discussions to enhance and diversify the growing defence partnership between India and Nigeria. Key areas of cooperation included counter-terrorism training, joint research and development, maritime safety—specifically hydrography and anti-piracy—and collaboration in the defence industry. Shri Seth showcased India's technological capabilities, highlighting platforms such as the Light Combat Aircraft, Light Combat Helicopter, and Offshore Patrol Vessels, and assured full support to Nigeria's defence modernization efforts. Both sides agreed to strengthen joint initiatives, with India inviting a Nigerian defence R&D delegation and Nigeria proposing reciprocal visits to explore investment opportunities. The meeting reaffirmed the longstanding, strategic ties between India and Nigeria, built on shared democratic values and commitment to deepening bilateral cooperation.

Seafood Exporters Meet 2025

Union Minister Shri Rajiv Ranjan Singh chaired the Seafood Exporters Meet 2025 in New Delhi, bringing together government officials, industry leaders, and progressive farmers to strengthen India's seafood export landscape. The meeting focused on strategies to expand global market reach amid challenges like high US tariffs. Singh emphasized increasing value addition in seafood products—from just 10% currently to up to 60%—and improving packaging, infrastructure, and certification standards to boost competitiveness. The government urged exporters to explore alternative markets such as the EU, Japan, South Korea, UK, Russia, Australia, West Asia, and Southeast Asia, reducing dependency on a single major market. Agencies like MPEDA were tasked to map state-specific export opportunities and facilitate infrastructure upgrades using funding support like the Fishery Infrastructure Development Fund. Stakeholders highlighted the need for streamlined certification, improved cold chain logistics, and incentives for value-added exports. The minister also reiterated the importance of developing domestic seafood markets for resilience and income generation, ensuring the government's commitment to addressing tariff and non-tariff barriers, and safeguarding the interests of exporters and fishers. This collaborative approach aims to drive sustainable growth, diversification, and innovation in India's seafood exports.
