

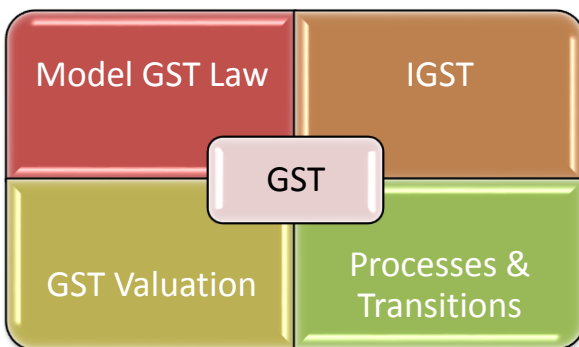


# DECODING & GEARING UP FOR DRAFT GST LAW
