SELECTION PROCESS

- 1. Questionnaire based assessment on the details furnished by the participating company and sharing relevant documents.
- 2. Finalisation of nominated companies, for assessment by the Jury and in consultation and co-ordination with ASSOCHAM.
- 3. Selection of the CSR projects for final recognition as per the categories above from the nominated companies by the Jury.



PANEL OF JURY MEMBERS

Entries will be judged by an eminent panel of senior corporate executives and academia representatives. The Jury evaluates entries based on innovation, local relevance of impact, integrated to company business strategy and governance mechanism, the most important benchmark will be to what extent the corporate has embarked on mainstreaming CSR and sustainability initiatives to centre stage and meeting all stakeholder expectations.
