Cabinet Decisions

Cabinet clears NH-326 upgradation to strengthen connectivity in southern Odisha

The Union Cabinet has approved the widening and strengthening of a key stretch of National Highway-326 in Odisha, upgrading the existing two-lane road to a two-lane configuration with paved shoulders. The approved project covers the section from Km 68.600 to Km 311.700 and will be implemented under the NH(O) programme on EPC mode.

The total capital cost is estimated at Rs. 1,526.21 crore, including a civil construction cost of Rs. 966.79 crore. The upgradation is expected to make travel faster, safer, and more reliable, supporting the overall development of southern Odisha, particularly the districts of Gajapati, Rayagada, and Koraput.

Currently, the Mohana-Koraput section of NH-326 has sub-standard geometry, narrow carriageways, sharp curves, and steep gradients that constrain the safe and efficient movement of heavy vehicles and reduce freight throughput to ports and industrial centres. The project will address these constraints through geometric corrections, curve realignments, gradient improvements, pavement strengthening, and removal of accident-prone black spots, enabling uninterrupted movement of goods and passengers and lowering vehicle operating costs.

The upgraded corridor will improve connectivity with NH-26, NH-59, NH-16, and the Raipur–Visakhapatnam corridor, while enhancing last-mile access to Gopalpur port, Jeypore airport, and railway stations. It will also strengthen links to major industrial, logistics, education, and tourism hubs, reducing travel time and supporting regional economic activity.

Economic analysis shows an EIRR of 17.95%, while the FIRR is negative, reflecting social benefits from travel-time savings, distance reduction, and safety improvements. The project is scheduled for 24 months plus five years of maintenance.

Approval granted for six-lane Nashik-Solapur-Akkalkot greenfield corridor

The Cabinet Committee on Economic Affairs has approved the construction of a six-lane, access-controlled greenfield corridor connecting Nashik, Solapur, and Akkalkot in Maharashtra. The project will be developed on BOT (Toll) mode, covering a length of about 374 km, with a total capital cost of Rs. 19,142 crore. It aims to improve connectivity between key regional cities such as Nashik, Ahilyanagar, and Solapur, with onward linkage towards Kurnool, and supports integrated transport infrastructure development under the PM Gatishakti National Master Plan.

The proposed corridor will connect to the Delhi-Mumbai Expressway near the Vadhawan port interchange, the Agra–Mumbai corridor at Nashik via NH-60, and the Samruddhi Mahamarg near Nashik. It will provide continuous west coast–east coast connectivity, complementing the four-lane corridors already under development from Chennai port to the Maharashtra border via Thiruvallur, Renigunta, Kadappa, and Kurnool.

Designed to improve travel efficiency, the corridor is expected to reduce travel time by about 17 hours and shorten distance by nearly 201 km. It will enhance logistics efficiency for freight linked to major industrial nodes, improve safety through access control, and ensure uninterrupted high-speed traffic movement. The project is expected to contribute to economic development in Nashik, Ahilyanagar, Dharashiv, and Solapur districts, while generating significant direct and indirect employment during construction and operation.

Overall

IIP rises by 6.7% in November 2025

Industrial output, measured by the index of industrial production (IIP), rose by 6.7 per cent on a year-on-year basis in November 2025. The growth was higher than the 0.4 per cent growth registered in the preceding month. The growth was the highest recorded in the last 25 months. Output of mined products grew by 5.4 per cent, but electricity generation fell by 1.5 per cent.

Food inflation to stay moderate in 2026

Retail food inflation is expected to rise moderately in 2026 after remaining in negative territory for the past six months, following a peak of 10.9 per cent in October 2024, reported Financial Express. Prices eased on the back of robust harvests, adequate imports and a favourable base effect. Economists note that the waning of this base will lift inflation next year, but levels are likely to remain well below 2024.

VE Commercial Vehicles receives Rs.1.92 billion GST demand

VE Commercial Vehicles (VECV), a subsidiary of Eicher Motors, has been issued a GST demand of Rs.1.92 billion by tax authorities for allegedly delayed reporting of credit notes in 2017-18. The original show-cause notice proposed a demand and penalty of around Rs.1.68 billion each, but the finalised order dated 29 December 2025 confirmed a lower tax liability of about Rs.961.8 million, along with an equal penalty and interest.

Credit-deposit gap widens to 200 bps as of 12 December 2025

The credit-deposit gap widened to 200 basis points (bps) as of the fortnight ended 12 December 2025. Bank credit grew 11.7 per cent year-on-year to about Rs.196.5 trillion, supported by a reduction in the goods and services tax rate, strong demand from retail and micro, small, and medium enterprises, early signs of industrial credit recovery and opportunistic corporate borrowings.

Coal India reports 3.7% fall in coal production during Apr-Nov 2025

Coal India reported a 3.7 per cent fall in coal production during April-November 2025, marking the first decline for this period in six years, as prolonged and intense monsoon rains disrupted mining activity. Output slipped to about 453.5 million tonnes, with mines in key eastern and central regions facing extended weather-related interruptions, while land acquisition delays added to the pressure.
