US tariff cut brings relief to textile exporters

The easing of trade tensions between India and the United States (US) has provided much-needed relief to textile and apparel exporters, according to media reports. On 2 February 2026, US President Donald Trump announced a reduction in reciprocal tariffs on Indian goods to 18 per cent from 25 per cent, along with the removal of non-tariff barriers.

Union finance minister announces 7 new corridors

FM Nirmala Sitharaman unveiled expansion of India's high-speed rail network, announcing seven new corridors to serve as powerful growth connectors. These include Mumbai-Pune, Pune-Hyderabad, Hyderabad-Bengaluru, Hyderabad-Chennai, Chennai-Bengaluru, Bengaluru-Varanasi and Varanasi-Siliguri. Among them, the Delhi-Varanasi and Varanasi-Siliguri high-speed rail projects stand out for their potential to revolutionise connectivity across northern, eastern and northeastern India.

Record rice output to support exports to US

A record kharif rice output of 149 million metric tonnes in India is likely to support exports to the United States (US). The US has reduced reciprocal tariffs on India to 18 per cent. The reduction in tariffs on Indian rice is expected to help India stay competitive in the US market against those from Pakistan and Thailand, which face a reciprocal tariff of 19 per cent.

Rising FCI costs may raise subsidy

The central government may need to raise food subsidy allocation by Rs.250 billion in 2026-27 from the budget estimate of Rs.2.27 trillion as Food Corporation of India (FCI) continues to hold surplus grain far above buffer norms, increasing storage and interest costs, reported Financial Express. The corporation's economic cost, which includes minimum support price, procurement, storage and carrying expenses, is projected to rise to Rs.4,391 per quintal for rice and Rs.3,145 per quintal for wheat in 2026-27, up from Rs.4,211 and Rs.2,968 in 2025-26.

IndiGo's capacity in March 2026 expected to grow by 10%: CEO

IndiGo's chief executive officer (CEO) Pieter Elbers said that capacity in the March 2026 quarter is expected to grow by around 10 per cent. This will be supported by steady aircraft deliveries averaging roughly one new plane a week, he said. Asia's largest low-cost airline, which suffered a severe operational disruption in the first week of December 2025 and cancelled about 2,500 flights over three days, has returned to operating more than 2,200 flights a day, carrying up to 380,000 passengers daily.

The recent reduction of US reciprocal tariffs on Indian goods to 18 per cent is expected to significantly benefit Indian auto component manufacturers by lowering costs, improving competitiveness, and enhancing plant utilisation. Vehicle original equipment manufacturers (OEMs) are likely to see only modest gains due to limited direct exports to the US and higher market entry barriers.

GAIL to supply gas to BPCL's Bina refinery for 14 years

Gas Authority of India (GAIL) will supply around one million standard cubic metres per day (MMSCMD) of natural gas to Bharat Petroleum Corporation (BPCL)'s Bina refinery for 14 years, from 2028 to 2042. To ensure a steady supply, a new 100 km Vijapur-Bina pipeline will be built.

The United States (US) decision to cut tariffs on Indian exports to 18 per cent from 50 per cent is expected to increase India's medical device exports. The lower tariff will make Indian medical devices more price competitive than those from China. Indian exporters will have an advantage, as Chinese suppliers face tariffs of around 30 per cent. India mainly exports medical disposables to the US, such as syringes, needles and basic accessories.

Andhra Pradesh

Andhra Pradesh gets highest allocation in Union railway budget

The Union railway budget has announced record allocations for both Andhra Pradesh and Telangana. Karnataka sees marginal rise in tax share under 16th Finance Commission

World Bank approves financing to upgrade India's ITI network

The Board of Executive Directors has approved an \$830 million loan to modernise India's Industrial Training Institutes under the Supporting Pradhan Mantri Skilling and Employability Transformation Through Upgraded ITIs (PM-SETU) Program. The initiative aims to align training with labour market demand, produce over one million skilled workers annually, and raise placement rates currently below 50 percent. It will mobilise at least \$680 million in private investment, promote greater women's participation, and operate through a hub-and-spoke model. The loan has a 19.5-year maturity, including four years' grace.
